Change is coming...

On paper, Medicaid (or Title 19 as it is sometimes called) covers almost every imaginable service, with zero payment due from the patient. Medicaid is quite complex and for the last 10 years, Iowa has seen rapid growth in total program costs now causing a deficit. The governor decided to address this growing deficit by asking for contracts with private health insurance companies for Medicaid beneficiaries through capitation (set) rates, Medicaid Managed Care Organizations (MCOs).





Case management will still be used but not the same way it occurs today. Case loads will be larger and cover larger geographic areas.



Home—the community and the least restrictive environments will still be the FIRST choice for service. For most individuals and families this IS the preferred choice.



Assessment - Clients will be assessed individually through a thorough process to determine needs an what services will be authorized and how much service will be allowed. Close monitoring should be expected.



No new dollars. The Medicaid system in Iowa is about \$50 million dollars in debt and growing. So every Medicaid client will be carefully monitored to assure that the service given does make a difference.



Governor Branstad used his executive power to ask outside managed care organizations to bid on the Medicaid system.



Education is critical. Recipients of Medicaid waiver services and supports should be asking questions about this new plan of service delivery. The Arc will also be working to keep you informed.
